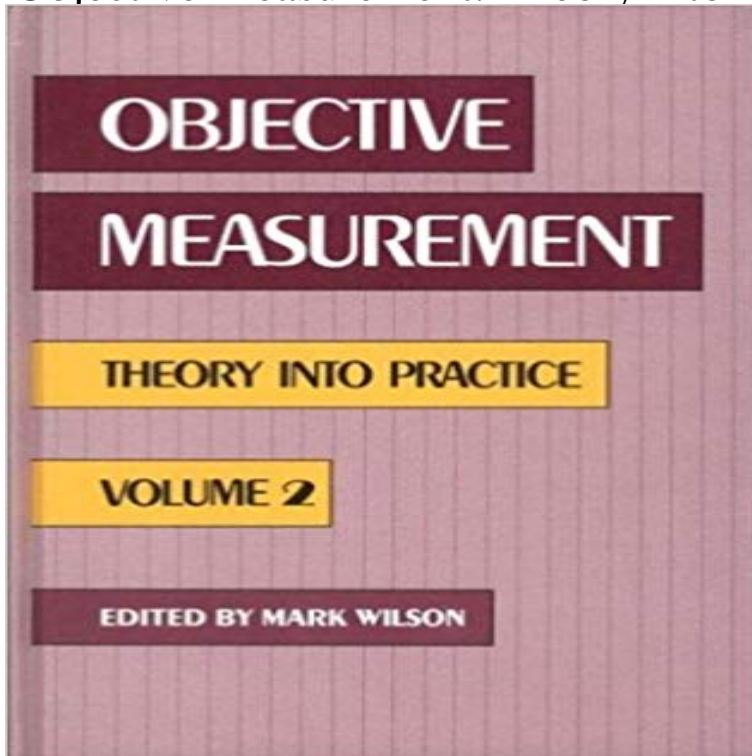


## Objective Measurement: Theory into Practice, Vol. 2
