


The European Unions Climate Change Policy: In the nexus of internal policy-making and international negotiations



The aim of the book is to examine the European Unions climate policy in the nexus of domestic policy-making and international negotiations. I firstly test the EUs internal climate policy-making by applying the rational choice institutionalism on the model of institution and preference affect EUs policy outcomes and conclude that: as the EU has a convergent preference, the EUs unique decision-making procedure, the entrepreneurship and EUs membership had been driving EUs climate policies into preferable outcomes. As the EUs preference is divergent, external factors affected the EUs divergent preferences and unified it to approve the ETS in the EU-wide. Second, I examined the relations between the EUs internal climate policy-making and international negotiations by applying the two-level game approach. The findings is that the Kyoto Protocol has a crucial impact on the developments of EUs climate change policies in terms of driving the EUs internal climate policy-making into a regulatory, centralised and market-based instruments direction. In return, EU climate change instruments, such as the EU ETS, are becoming more influential at the international climate negotiations
