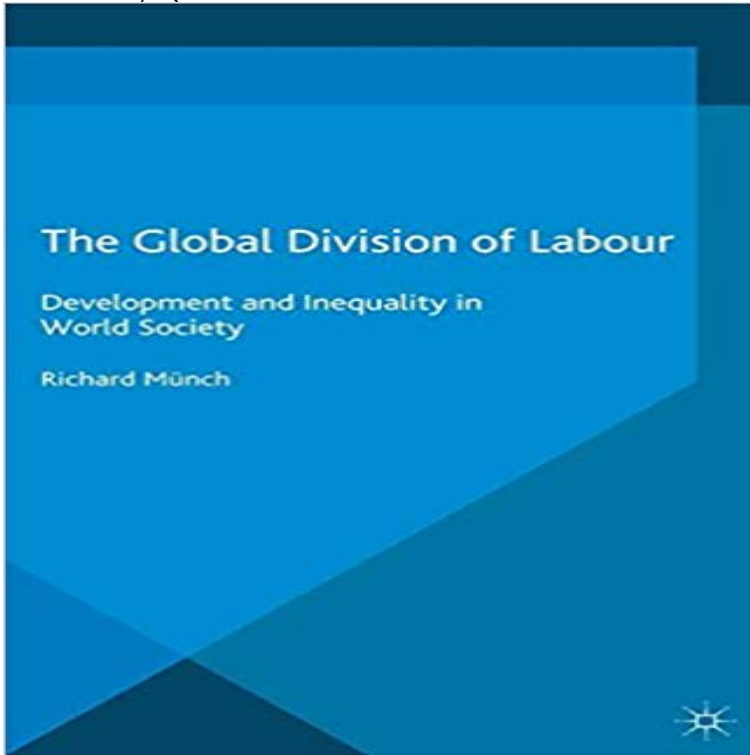


# The Global Division of Labour: Development and Inequality in World Society (International Political Economy Series)
